2015 CIL Needs Assessment Survey Report

Introduction

This report contains a statistical analysis of the results of the survey sent to Centers for Independent Living in March 2015. The purpose of the survey was to obtain feedback from the CILs about their anticipated training and technical assistance needs related to changes made by the Workforce Innovation and Opportunity Act, as well as overall areas of concern in operating centers for independent living.

The Workforce Innovation and Opportunity Act (WIOA) adds a fifth core service (with three parts) for CILs, and re-defines how the Statewide Independent Living Council will involve the CILs in the state in developing and evaluating the implementation of the State Plan for Independent Living. There were 108 respondents, but the total count in each response will be greater than 108 because each question had multiple potential answers.

QUESTION 1: What training or technical assistance will be needed by your CIL to implement the new 5th core service of "transition" (i.e. facilitating the transition of individuals with significant disabilities from nursing homes and other institutions to home and community-based residences; providing assistance to individuals with significant disabilities who are at risk of entering institutions so that they may remain in the community; and facilitating the transition of youth who are individuals with significant disabilities, who are eligible for individualized education programs, who have completed their secondary education or otherwise left school, to postsecondary life.)
