Review of Day One

- Yesterday, we covered a lot!
- We started with an overview of why housing is important, and how housing specialists serve a very special role.
- We looked at basic housing concepts and public policy.
- We also took a brief look at resources for housing.

Review of Day One, cont'd.

- Then, using Kay as a way to make these concepts more real, we spent time exploring how to support real choice.
- Again, why is this important?
- And, we practiced with tools that can be used with anyone who might want to move into their own place.

Review of Day One, cont'd. 2

- Finally, we looked at money!
- A hard look at finances is often discouraging, and people who have been out of the housing market for a while are likely to have sticker shock! We explored how to support choice even in tight housing markets.

Day Two

- Today, we are going to look at how to find housing – where to look and how to help people make informed choices. This is where the housing specialists expertise is essential.
- And, making the transition itself requires your expertise, lots of preparation, and supports and services.
- Finally, we'll talk about some issues that can cause problems and how to help tenants deal with them.

Finding Housing

- Let's talk about how to find housing.
- The housing specialist is the expert. YOU know neighborhoods, community amenities, landlords, public transportation, shopping, and the location and the requirements for all sorts of subsidized housing.

Finding Housing - PHAs

- What is the situation with your local PHA?
- Is the waiting list open or closed?
- Does the housing authority operate its own units?
- Who is the director? Where are the offices? Who are the key managers?
- Your desk should be littered with business cards, applications, addresses.

Finding Housing – PHAs, cont'd.

Here's what you should know or have on hand....

- Where are the PHA units (if they operate units)?
- What is the process for getting on that list?
Have a copy of the rules, the application, the list of documentation required.
- Where does someone go to apply for HCVs?
You should have a copy of the application, requirements, etc.
- What are eligibility requirements for both types of programs?

Finding Housing – PHAs, cont'd. 2

Does your PHA participate in specialty programs?

- Did they apply for the “non-elderly disabled” vouchers in summer 2011?
- Do they participate in home ownership programs?
- Do they receive funding for set-aside units?

Do they set preferences in the HCV program?

Finding Housing – PHAs, cont'd. 3

Look up YOUR PHA's plan.

Finding Housing – PHAs, cont'd. 4

- What is required to participate in these programs?
- Often, there is an orientation session that must be attended in person.
- Usually, people have to respond to mailed requests for updates, just to stay on the lists.

Finding Housing – PHAs, cont'd. 5

You can help people:

- Get on the lists for PHA units and HCVs. Note – assembling the documentation for these programs will help you with every other step in the process. Better to find out up front if there are documents missing.
- Educate themselves about what will be required, so there are no surprises.
- Advocate for reasonable accommodation where PHA rules or procedures constitute a burden.

Finding Housing – PHAs, cont'd. 6

You can help people:

- Understand what the rules will be once they move in.
- Meet requirements like answering mail and attending meetings.
- Be realistic about timelines.
- Plan for these options.

Finding Housing – Other Subsidized Units



- What other types of subsidized housing are there in your community?
- Building on what we said yesterday, you want a list of projects that have been assisted through ConPlan funds. This should be available through your city offices.
- Most of these projects will still NOT be affordable without a subsidy, but it is your job to know.

Finding Housing – Other Subsidized Units, cont'd.



CONPLAN QUESTIONS:

- You want a list of the projects funded or supported with HOME funds.
- You want to know if your jurisdiction uses HOME funds for rental assistance.
- You want to know if the CDBG program has funded any housing projects.

Finding Housing – Other Subsidized Units, cont'd. 2

Section 811 programs

- Historically, this program has funded segregated units serving people with disabilities, and providing services.
- Just last year, HUD made significant changes to how this program operates that will make it more likely to result in the development of integrated housing units.
- You probably have some 811 programs in your community.

Finding Housing – Other Subsidized Units, cont'd. 3



Section 202 programs –

- This program provides funding for construction and operation of housing for people who are elderly. (Note – elderly is often defined as age 55 and older).
- Like 811, the program is undergoing change.
- You probably have some of these programs in your community.

Finding Housing – Other Subsidized Units, cont'd. 4

Finding Housing – Other Subsidized Units, cont'd. 5



- Low Income Housing Tax Credit properties.
- You will also need a list of LIHTC properties. LIHTC is operated by your state housing agency, and most state agencies offer a list of assisted properties.
- Most LIHTC properties will not be affordable without additional subsidy, but it is your job to find out!

Finding Housing – Other Subsidized Units, cont'd. 6



- Affordable housing developers
- Look in your community for Community Development Corporations (CDCs) or Community Housing Development Organizations (CHDOs).
- These are the people who are building affordable housing and may be good allies.

Finding Housing – Other Tips

- You might want to cooperate with other housing specialists or other agencies in developing a community wide directory of all of this information.
- You want to know eligibility, rent, amenities, rules, vacancy status.
